Illinois 1F Cash Advance loan agreements are governed by the State of Illinois

### Loan Details

Loan Amount	Repayment Period	Maximum APR*
\$500 - \$5,000	2 - 24 months	36%

### Representative Examples of APRs and Finance Charges

Under the 205 ILCS 670/15, the maximum APR\* on an installment loan is 36%. Check out the examples of fees for different loan amounts:

Advanced Amount	APR*	Loan Term (months)	Monthly Payment	Total Cost
\$500	12.81%	3	\$170.24	\$510.71
\$1,000	18.76%	6	\$175.90	\$1,055.42
\$2,000	24.98%	12	\$190.07	\$2,280.83
\$3,000	29.99%	18	\$209.00	\$3,761.91
\$4,000	31.54%	20	\$259.71	\$5,194.19
\$5,000	35.99%	24	\$295.21	\$7,085.05

\*Annual Percentage Rate: The APR is the cost of your loan expressed as a yearly rate.
